The Great Outdoors (GOD) Special Permit Application 2021 Tube and Equipment Rentals and Retail River Parking and Shuttle Service. Concession and Retail

Purpose: GOD hopes to offer a safer and more enjoyable river experience to tourists and tubers by continuing to offer riverside parking, and shuttle service in addition to a retail store. The proposal is designed to enhance the experience of river tubers by helping to provide a much needed solution to the problem of overcrowding along the river which results in dangerous situations both in and around the river. The proposed services will bring parking to a central location near restaurants and stores, provide safety information through our website and brochures, provide trash and sanitation facilities, enhance upfront monitoring for alcohol and marijuana use, help control misuse of privately owned river frontage through adequate signage, and reduce overcrowding at river access points by keeping parking in a central location. The shuttle service will help enhance control over what goes up the river by having staff monitor who is using the river and to observe for any safety irregularities. It will provide legal, safe and clearly marked point access to and from the river. Please note that this special permit is addressseing a "forcast" of what we expect to what direction we expect to go and offer for the next 10 years.

Trips: GOD will offer two river run trips:

- The first trip with shuttle passengers up to the Zoar picnic area, where they will tube back down to the take out at Flag Pole Point at the GOD. Tubers on that section of the river will not be shuttled after 3 pm, depending on the river release.
- The second trip called a "Float Trip", which will probably not be offered until next year,
 will allow tubers to float from GOD down the I-II rapids to the take out just north of
 Shelburne. They will be shuttled back to the GOD. Berkshire and Crab Apple both offer
 similar trips.

Education: GOD website provides detailed information key to river safety.

Please go to www.greatoutdoors-deerfieldriver.com. From there users can connect directly to Safewater river flow report for up to date info on river releases and explanation of flow rates. Addidtional emphasis is placed on no profanities, harassment of others, loud noise & music etc. A map of the river and access points and river rules plus a river waiver are downloadable plus provided at the check-in. (see attached)

There will be signs/posters warning about ticks and Brookfields "SHARE THE RIVER SAFELY" and WEAR IT" posters.

Traffic Flow

UPPER LOT: The traffic will enter and exit off Main Street/ Rte 2. (see traffic control designs) Site lines are excellent in both east and west directions. There has never been an accident in the ten years of operation.

In the upper lot customers will be allowed to park short term in order to purchase tickets or buy retail. Picnic tables 4-6 tables will be available for people to regroup and to fill out forms

There is a stop sign warning vehicles to stop and slow down as they exit onto route 2. Cones and painted arrows on drive, will help to divide the in and out lanes

Discussion was initiated with DOT when they were planning the new highway and they agreed to further widen the entrance to the upper parking lot.

LOWER LOT: Traffic will flow into the lower lot and be greated by a parking attendant who will direct them to the proper parking space. Spaces will be identified by a series of small flags as we have done successfully in the past.

Lot lines: GOD will respect property regulations for 10 foot set backs and sidelines. GOD will work with abutters. This has not been a problem in the recent past.

Hours of Operation: The Great Outdoors retail store will be open from 10 am to 7pm, 365 days a year. GOD Shuttle service and tube rentals will be open 7 days a week from May15th until October 15th. It will open at 10 but will also depend on water release.

Shuttle Services: Park and shuttle operation will be linked to the Great Outdoors.

GOD will provide shuttle transportation for customers who have rented or purchased tubes and other safety equipment (commercial users) and for users with their own tubes that park in the lot and use the shuttle van and do not rent equipment. It will expand to include other tubers and tourists who only wish to park. It will not shuttle users to cars parked in other locations.

The shuttle vehicle will either be 8 passenger vans with trailer for the tubes or commercial Kuzmescus school buses, the number depending on the need. The shuttles will run continuous loops.

Private tubes will be inspected for river safety worthiness. Large floating pool toys (my Pony is a favorite) will not be allowed. Shuttle riders will be screened for alcohol, tobacco products, glass containers etc.

Vans are be fully insured.

The shuttle will run on a regular loop as volume and river release dictates.

Regulations Minimum age will be in accordance with 323CMR 6.03.4. Children younger than 15 must be accompanies by an adult (18).

Parking: Parking will be in accordance with the attached plan.

A parking area attendant will be stationed at the entrance to the back lot and direct parking to the appropriate lanes. The attendant will have a hand held counter. They will also give a visual inspection of the contents of the car and provide each car with a handout addressing such things as trash, alcohol, river rights etc. Cars will not be searched.

No one will be allowed to remain in the back lot after 7pm. Overnight parking is prohibited.

Signage will be at the entrance to the lot.

River Access: Flag Pole Point (FPP) will be the only point of access to and from the river. It will be clearly marked. Has not been a recent problem. There will be no swimming or picnicking allowed along the river's edge with proper signeage. It will be strictly enforced. Two to four Adirondack chairs will be allowed there.

Monitoring of the property: There will be surveillance cameras to monitor each field with central screening area inside GOD.

Sanitation: The GOD is linked to town sewage. There is a private water supply. River users will be encourage to "take out what they bring in". A large dumpster also will be located on the premises. Carson cans (porta potties) will be situated as to best providing screening. Number will depend on demand. We had two last year which worked out fine. They are emptied and cleaned weekly. The area will be swept for garbage/trash at the end of each day and deposited in dumpster.

Signage: A sign will be at sign at the entrance directing drivers into the upper lot at GOD. There will be multiple directional signs on the property directing participants on where to park.

Will be a sign in front of building with "River Shuttle and Parking" 3 x 4.


River signs will be needed to post along the river so direct tubers etc to "take-out" area and " at Flag pole point and no trespassing" signs to protect abutters.

A sign at the entrance to the back field stating hours of operation and that area will be closed to all cars after seven. They will be removed at the end of the season. A lot full sign will be placed once the lot has reached capacity.


Lighting No change since operation occurs during day light hours.

Final Thoughts: Tubing companies are not the problem but an important part of the solution to the various problems associated with river use


Remember that the 300 commercial tubers who will use both tubing companies, rent a tube with all the safety advantages that come with it (listed above), that means there will be 300 less unprepared tubers who will be out there free-wheeling. Each car one sees in the GOD parking lot would instead be out searching desperately to find a spot where ever they could find one upriver.





Figure 1. Example design for 150 parking spaces per acre with 10' by 18' spaces.

If a field that is 180 feet by 242 feet (approximately 1 acre) is designed with six rows of parking spaces with each parking space being approximately 10 feet by 18 feet and the traffic lanes are 24 feet wide, approximately 150 spaces can be designed. As shown in Figure 1, there are three pairs of parking rows, each containing 48 spaces. The one-way traffic lanes are 12 feet wide and the two-way traffic lanes are 18 feet wide.



Safety tips for the river

The Deerfield River Water Release



The Deerfield River flow rises and falls as water is released from the upper dams. The Great Outdoors will post the releases every day. The flow is measured in cubic feet per second (cfs). A flow of 850 is normal. Use caution with higher flows. Medium flow is 700-1200 cfs. Water is usually released between 9:30 and 12 noon and is guaranteed to be at least 700 cfs's.

For river flow you may call 1-800 452-1737 and enter the six digit codes for the Fife Brook Dam which is 255123

All published flows are approximate and forecasts are estimates only. Actual flows will vary and can change quickly at any time.

Tube Safety

- All river activities have unknown potential dangers. The river is unattended. You
 will be on your own. It is unwise to tube alone.
- Children under & must wear life vests and be accompanied by an adult.
- All tubers should be physically capable and be old enough to use the tubes wisely.
- The tubes are not puncture proof. Beware of sharp edges sticking out of the water. Do not smoke while rafting, you may pop tube
- Alcohol is prohibited.
- Do not liter. Dispose of trash in the proper receptacles.
- You should wear water-shoes or teva-type sandals. Do not wear flip flops.
- Use waterproof pouches as necessary and floating key chains, which are available at the great outdoors. Leave all unnecessary items in your car.
- Should you fall off your tube DO NOT stand up. Your foot may become
 entrapped and it may be difficult to release it against the strong current. You
 should float with your feet straight out in front of you as you paddle your way to
 calm water where you may stand.
- Watch out for fellow tubers and help out should they be in difficulty. Stay away from fisherman and avoid their lines.
- · Respect private property. Do not trespass. No abusive ads, loud music
- The weather cannot be controlled. It can change at any time. Should a thunder storm occur, quickly float to the river bank and wait until it subsides.

Always be alert and wear an approved flotation device. Never go in or near the water until you know and accept the risks you are assuming by being on the river

Be safe and enjoy your river trip. Help keep the river beautiful.
