CHARLEMONT SELECTBOARD MEETING MINUTES

Monday, October 15, 2024, 6:30 pm in person, Town Hall Meeting Room, 157 Main Street, Charlemont

Jared Bellows called the meeting to order at 6:30 PM.

Appointments:

6:30 PM – Thorne Palmer Re: appointment of election workers.

Thorne recently learned that the election workers need to be appointed by the Select Board.

Jared Bellows motioned to appoint all of the people Thorne read from the list of election workers. Kim Blakeslee seconded the motion. All in favor.

Administrator reports:

1) <u>Effects of Massachusetts emission standards legislation on medium and heavy-duty</u> vehicle (highway trucks) availability starting in model year 2025 production.

In 2021 Massachusetts adopted California Motor Vehicles emissions standards to start in 2025, for heavy and medium duty trucks. As of January 1st, 2025, diesel trucks are not supposed to be purchased. Emergency and public vehicles are exempt from this. The plows and dump trucks are included. The problem is that 0 emission trucks are not available. Also, the charging infrastructure is not there yet. The Rural Director is talking to the DEP, many states have delayed the enactment because of non-availability of vehicles and the hope that the technology will advance. Multiple towns have large obstacles. Sarah gave the Select Board the information so that they can read up on it.

2) Budget Program Grant from DLS, quotes and next steps

The Town was awarded the grant. Jared asked to postpone the topic for the next meeting when Val will be present.

3) Response from Shelburne about bottles and cans collections at transfer station

The can receptacle building at the transfer station was built by the Mohawk Athletic Program, so the proceeds will stay with the Mohawk Athletic program. It was good to have the conversation. They will be better about emptying it and have provided a contact person.

4) Colonial and Aflac Quotes for accident insurance

Town employees who pay into retirement do not pay into social security. If someone gets hurt, they will be without coverage, as they are not eligible for social security disability. Sarah asked around to other towns to see what they are doing and got quotes from Colonial and Aflac. Val and Sarah decided on Colonial as it's user-friendly and the reps are more local. Employees can choose a plan from different tiers. The plans need a few subscribers to start. if people withdraw later it wouldn't mess up the run for the other employees. They will bring the topic up with the finance committee next year to

discuss the employer contribution. Jared Bellows made a motion to grant Sarah Reynolds the authority to do that. Kim Blakeslee seconded the motion. All in favor.

Liaison reports and actions:

1) Town Hall Telephone System quote received

Val emailed Jared that he met and worked with Microsoft phones and was exploring the challenges and the new equipment. He has not billed the time to the Town.

2) Council on Aging **item not foreseen last 48 hours.

Kim Blakeslee attended the Council on Aging meeting. There were many questions regarding Senior Housing and what the Select Board is doing to address and communicate regarding the need for housing for the elderly in Town. Kim told them she would bring it up at the meeting. Kim will call Linda Wagner to see who manages the budget.

Agenda items:

- 1) Discuss a new tax title taking process policy to incorporate statute changes.

 State Legislature changed the Tax title taking process. Charlemont's parcels are usually vacant land.

 KP Law sent an update with bullet points on how it would affect the town. Sarah talked to Lynn Hathaway and Val and printed an email based on the KP Law update, it will be edited for Charlemont, then sent to the attorney, to be voted at the next meeting. Lynn has okayed the policy. The Board are thinking that the only way to afford the new process, which requires a real estate agent, is to batch them and do them annually in October. It will impact the people who are in tax title. The interest rate is currently 16% and will drop to 8% for new cases after November 1st. Previous balances will remain at 16%. Jaren Bellows motioned to send the policy to the attorney. Kim Blakeslee seconded the motion. All in Favor.
- 2) EV Chargers at Hawlemont update and paperwork for National Grid make ready application This paperwork is to authorize National Grid to do the make-ready preparations ahead of the chargers being installed, there will be no cost to the Town. Jared Bellows motioned to move ahead with the National Grid make ready work and to sign the paperwork. Kim Blakeslee seconded the motion. All in favor.
- 3) Letter from Shelburne Falls Fire District about ambulance service to Hawley, and letter from Hawley about exploration of a regional Paramedic Ambulance Service.

 The Board reviewed the letter and spoke about the most likely causes for Shelburne to stop taking calls in Hawley, staffing and cost. The Board reviewed the request from Hawley to form a regional paramedic ambulance service in Western County. Jared will work with Sarah to get Dana (Ambulance director) to the next meeting, with Hawley, to address the issue quickly.
- 4) <u>Letter about United States of America's 250th Anniversary and possible commemoration</u> <u>activities for Charlemont.</u> The Board read the letter from Marguerite Willis. The 250th anniversary will happen in 2026. Kim Blakeslee will reach out to Marguerite.

- 5) Request for Proposals for Fairgrounds Exhibit Hall and Parking Upgrades- review and next steps. The RFPs have not changed since the last version. Mike Hayden brought it back to Parks and Rec; everyone had a chance to see them. Sarah let the Board know that she has a request in for the DCR bathroom plans and info and hasn't heard back yet. Jared Bellows motioned to move forward the Requests for Proposals. Kim Blakeslee seconded the motion. All in favor.
- 6) Town Cori Procedure for hiring employees.

Val and Sarah chose a model CORI policy from the State. Town departments can fine tune the policy for their purposes. The Board, including Val, are good with the policy. (Kim read from an email that Val sent.) Jared Bellows motioned to accept and make this Charlemont's policy. Kim Blakeslee seconded the motion. All in favor.

7) <u>Bridge over Deerfield River "Long Bridge" proposal for park/bench type area on Department of Transportation property at end of Bridge</u>. Val wrote a letter and sent it to MassDOT that a suggestion came up to put a park bench on their property.

Jared Bellows made a motion to sign the payroll and vendor warrants. Kim Blakeslee seconded the motion. All in favor.
